The year 2006 has just concluded with mixed sentiments. Like other years, 2006 too has seen its share of joys and sorrows, laughter and tears. For us, 2006 was a year of challenges. We began the year with the construction of our office-cum-programme center. Constructing a building is not an easy task. But we are now at the final stages and hope to inaugurate the same by the end of February 2007. Because of lack of a proper office we rented a small premises, but in October we had to move out as the Landlord wanted to pull down the building. We are now working from a small room measuring ten feet by ten feet! The lack of place had an immediate impact on our childrens' programme, which had to be suspended. And so it was, one challenge after the other.

However, we also had a fair share of good things that happened to us. Our programme for the care of disabled is getting shape. We have been able to reach out and educate more children this year. Though your donations have dwindled in 2006, the love that God and people have for us has only grown. Our enthusiasm has not diminished and our energy to *reach out in love and service* has not been lost.

It is with these sentiments, we believe that it is time for us at We Care to remember each and every one of you with immense gratitude and appreciation. It is with your generous hands that we have been able to continue to reach out to hundreds of people who need help so desperately. You are indeed persons who **truly care**.

As in previous years, we continue to focus on two main programmes: **EDUCATION & DISABILITY**.

EDUCATION ASSISTANCE: During the academic year 2005-06 we were able to reach out to over 900 children, providing them

with assistance towards their education: books, uniforms, mid-day meals, etc. The total expenditure towards education assistance in 2005-06 was Rs.13,58,746/-

Students from St. Paul's High School and Joseph's Girls High School, Belgaum; St. Maryknoll High School, Barkur, Udupi; St. Benedict's Higher Primary School, Bangalore; Franciscan Institute Higher Primary School, Bangalore: Basic Education for Social Transformation, Wankaner, Gujarat; and other local schools received financial assistance towards books,

uniforms, tuition fees, mid-day meals, transport and other expenses. During the year we provided financial assistance to 15 nursing students studying at the Holy Cross School of Nursing, Kamagere.

The major donors towards this expenditure were: Amici di Raoul Follereau, Bangalore; Hands of Hope Ltd, Ireland, John & Theresa D'Souza Memorial Education Fund; Velthoria & George Sequeira Education Fund; Osborne & Ella D'Lima Memorial Education Fund and many individual donors.

Nehru Children's Club Today's children are the future of our tomorrow. 'Get organized for the better cause' is a phrase, which motivated us to organize the children to form the "Nehru Children's Club". Under the guidance of Bhavani and Srinivas these children had regular tuition classes every Monday to Friday. On Saturdays, special programmes were conducted for them to explore and develop their talents through creative activities like singing, dramas, role-play, etc. Every Sunday, music classes were conducted for those who were interested by the OMI Brothers, Nivedanam Bangalore.

During the evening tuition classes, the children were made part of the **nutritional recovery programme**. Medical check-ups are provided at regular intervals. Nutritious food like ragi-porridge, ragi-mudde, eggs, milk, grains, pulses etc. were also served to the children.



Celebrating various cultural events and festivals helped the children to develop a broad spirit of tolerance and openness. Various events like Deepavali, Children's day, Teachers' day etc. were celebrated during the year.

The children are also encouraged to involve themselves in **social activities** like polio immunizing programmes, cleaning of the surroundings and CBR programmes.

These children look bright and cheerful. They are grateful and highly appreciative of the activities

conducted for them. They acknowledge that these programmes have changed their lives for the better. They are now able to study well and feel they have the support to become someone different.

The children's programme is being supported by **AMICI** and the income from **Children's Welfare Fund.** We are grateful to Madhu and her friends for their assistance in carrying out this programme.

We Care supports a nursery class for the poor children from the local areas. We Care provides the financial support towards running of the Nursery Class while the FMM sisters look after the administration and management. In 2005-06 about 65 children received education in this nursery class. The activity is carried on with the help of Sr. Nancy, Headmistress; Mrs Meenakshi, Teacher and Mrs Thomas Rose Mary, Caretaker.

Basic Education for Social Transformation Programme: In collaboration with the Franciscan Clarist Congregation and in particular with the Sisters of the Premal Jyothi Convent, Wankaner, Gujarat, We Care has been able to educate 100 children each year in the rural areas of Gujarat. The children are selected from the nearby villages and sent to local schools. Common tuitions



and cultural activities are provided to help the children. In the year 2005-06 the total expenditure on this programme was approximately **Rs.60,000/-**

Nursing Education: In collaboration with the Holy Cross School of Nursing, Kamagere, Karnataka, We Care was able to educate fifteen young girls in the **nursing profession** during the year. In the year 2005-06 the total expenditure on this programme was approximately **Rs.1,60,000**/-

Mid-day Meals: were provided for about 115 children in two schools: Franciscan Institute of Higher Primary Education and St. Francis Xavier's Higher Primary School, Bangalore; about 100 children in

Maria Kirana Creche, Bangalore; about 20 children of domestic workers in Regiguda Slum, Bangalore and about 25 children of the Nehru Children's Club. The expenses for this programme were met by **AMICI Di Raoul Follereau**, the **Soroptomists Project, Bangalore and your donations**. Our sincere thanks to all our collaborators and especially to Maria Seva Sangha for their assistance in carrying out some of these programmes.

COMMUNITY BASED REHABILITATION PROGRAMME (CBR) FOR PERSONS WITH DISABILITY (PWD'S): The CBR programme is carried out in over 28 villages of Urban Bangalore, South Taluk. Through the door-to-door survey and information received from the local leaders and government departments, we identified 998 persons with disabilities.

Various programmes were conducted for the people with disabilities which included the World Disabled Day celebrations; awareness programmes for school children, teachers and women's groups; awareness on leprosy; formation of self-help groups for the disabled; self-employment programmes; non-formal education; social security programmes; providing aids and appliances; etc.

The following benefits were provided to persons with disability: Training of staff members 12; 17 Training programmes for general awareness covering over 3400 persons; 72 persons were issued medical certificates and train concession passes; 27 persons received government scholarships; 43 persons were issued new I.D. cards; 12 persons received home based education; 51 persons received physiotherapy; 13 persons received speech therapy; 26 persons received aids and appliances (i.e., hearing aids, crutches,

calipers, etc.) and 42 persons received occupational therapy (i.e., activities for daily living skills)

The CBR programme is carried on with the help of our well trained and motivated staff lead

by our CBR Programme Coordinator, Sagayaraj. Our field staff consists of Jayamani, Amala, Muni Swami Rao, Leelavathy, Meena, Premila, Sanjay, Dharaj and James. Our office staff consists of: Srinivas (Disabled), Micheal Anthony and Anitha Joy. We are grateful to our staff for their dedicated service.



We Care earnestly promotes inclusive education while also focusing on the disabilities of the students. Madeva, was identified with severe mental retardation in the year 2005 at Roopeagrahara village. Our CBR staff, Ms Meena was informed by Madeva's mother that he did not attend any school because of the teacher's unwillingness to accept him and also because of the school's negative and non-cooperative attitude. Thus, he lost two years of schooling before we met him. Ms Meena recognized Madeva's interest in studies and encouraged him. She keenly observed his activities and interests, and set-up an individualized educational programme. She also encouraged other teachers to do like-wise. With persuasion and determination Madeva was admitted to Sai Baba Primary School and now studies with normal children. His parents and family are very happy about his progress and are thankful to We Care for our timely intervention.



MEMORIAL and CORPUS FUNDS: We Care is grateful to many people who have donated towards Education, Health Care, and other Charity Funds. During the year two new memorial funds were set up: Prudente and Fatima Menezes Memorial Charity Fund and Beatrice and Charles Noronha Memorial Charity Fund. We also set up the We Care Education Fund and We Care Building Fund. With this we now have twenty-four Corpus and Memorial Funds. The income from these funds will be utilized to meet the expenses of various progammes.

LIFE STORIES OF MARIYAPPA, SRIDEVI AND KUTTI

Mariyappa, aged 10 years, is the eldest son and Sridevi, aged 7 years, is the eldest daughter in the family - among the five children to their parents. Both of them are suffering from loss of hearing since their birth. The family has migrated from Gulbarga to Bangalore for earning their livelihood. Being poor, proper medical treatment, schooling, etc. was out of their reach. Ignorance, Illiteracy and lack of awareness of their parents also added to the problems of the family. Though they were assessed and provided with hearing aids by the government medical workers, they did not know how to use them. Ms. Jayamani, our CBR staff, identified both of them and taught them how to use the hearing aids. Besides, both the children were admitted to Sai Baba School



after creating awareness in the family and among the local community. Today both, Mariyappa and Sridevi are happily studying and enjoying their childhood. Their parents have expressed their thanks to We Care project for their timely intervention and support.

DISABILITY IS NOT A SHAME: We just need to motivate and make the person accept it! We all know that some forms of disability are hidden, but we should understand

community attitudes, beliefs, myths, misconceptions and act accordingly.

Mr. Kutti lives in Subhas Nagar, Bangalore. He is aged 35. Both his hands were amputated after an electrical accident. From then onwards Mr. Kutti became shy, frustrated, and hesitant to show his hands. He would move about by covering his hands with a towel. Ms. Leela, our CBR staff, came in contact with him and studied his case. She began to counsel and motivate Mr Kutti. This was done with the help of films, pictures, and listening. Slowly she began to see a new mind-set emerge with a change in attitude. Mr Kutti accepted himself and the disability. Slowly he began to move around without covering his amputated hands. Leela achieved this feat within 1 year – a truly great acheivement!
